YMCA 'LTS Winter Superhero Competition' PROMOTION - TERMS AND CONDITIONS (Terms)

1. OFFER AND ELIGIBILITY

- a. This 'LTS Winter Superhero Competition' (**Promotion**) is offered by Victorian YMCA Community Programming Pty Ltd (ABN 75 092 818 445) of 502/990 Whitehorse Rd, Box Hill VIC 3128 (**YMCA**).
- b. By participating in the Promotion, you agree to be bound by these Terms.
- c. The Promotion is available at Ashburton Pool and Recreation Centre, Hawthorn Aquatic and Leisure Centre, Warragul Leisure Centre, South Gippsland SPLASH, Peter Krenz Leisure Centre, Benalla Aquatic Centre, Numurkah Aquatic and Fitness Centre, Coburg Leisure Centre, Brunswick Baths, Fawkner Leisure Centre and Horsham Aquatic Centre (**Participating Centres**) between the dates and times of 06:00am on 2 June to 11:59pm on 29 June 2025 (**Promotion Period**).
- d. This promotion is open to all enrolled Learn to Swim participants aged 3–12 years at Participating Centres during the Promotional Period.
- e. The Promotion is not valid in conjunction with other offers, unless approved in writing by YMCA.

2. SIGN UP TERMS

- a. Eligible participants will be in the draw to win prizes:
 - i. Each participating Centre will conduct its own prize draw.
 - ii. Prizes will vary by Centre but will be valued at a minimum of \$200.
 - iii. Details of each Centre's prize(s) will be displayed at the facility.
 - iv. Prizes are not transferable or redeemable for cash.
 - v. Prize draws will take place on Tuesday 1 July 2025. Winners will be selected at random from eligible entries and notified via phone.

To enter the draw, participants must:

- b. Collect a Winter Superhero worksheet from their Centre.
- c. Attend all four Learn to Swim classes during the competition period.
- d. Complete the designated weekly activities.
- e. Have their attendance verified and stamped each week by an authorised staff member.
- f. Submit their completed worksheet to the Centre by the deadline.
- g. In the event a public holiday falls on a participant's usual swim day, attendance for that week will be granted automatically.
- h. Only one entry per participant is permitted.
- i. Late or incomplete worksheets will not be accepted.
- j. YMCA reserves the right to verify entries and disqualify any entrant who tampers with the entry process or does not comply with these terms.
