The Promotion is available at Ashburton Pool and Recreation Centre, Hawthorn Aquatic and Leisure Centre, Warragul Leisure Centre, South Gippsland SPLASH, Peter Krenz Leisure Centre, Benalla Aquatic Centre, Numurkah Aquatic and Fitness Centre, Coburg Leisure Centre, Brunswick Baths, Fawkner Leisure Centre and Horsham Aquatic Centre (Participating Centres) between the dates and times of 06:00am on 2 June to 11:59pm on 29 June 2025 (Promotion Period).
